The Yap State Public Service Corporation Representatives shall limit their activities on the premises to inspection, maintenance, and purposes relating to these services, i.e., give due regard and respect to the owner's property.

The applicant agrees that the YSPSC shall have the right to discontinue any or all services on due notice from the premises whenever bills for any service are delinquent. Bills shall be considered delinquent if not paid within thirty (30) days after presentation to the applicant.

Reconnection charges for electric-service shall be \$50.00. Applicant agrees to pay the charge prior to reconnection.
